

Pittsburgh Specifiers Roundtable

What: Topic - DIVISION o1.

Having resolved all potential issues in Division oo, the next logical step is Division o1. This hub of the project manual, as identified by Figure 7.1 in CSI's Construction Specifications Practice Guide, should be fully understood by all of those on the design team. In Division o1 we will again consider: various issues that can present issues during construction; how contracts affect its preparation (single vs multi-prime); issues with using Owner provided Sections; delegated design related text; your experiences; and various other topics as time permits. Even though parking lot signs say 'leases only', there is FREE parking around the entire building; it is best to park opposite the restaurant (on the river/south side of building). You do NOT need to check-in at the front desk (north side of the building) prior to eating lunch at the restaurant. As usual, we will try to reserve the 'back room' with various sports memorabilia. 
