Denny Buirge describes his first time attending the CSI National Convention.

#### **CSI CONSTRUCT 2019 - CONVENTION BULLET POINTS**

#### **TUESDAY**

Leave Pittsburgh office about 3:00 PM and arrive about 7:15 PM at Gaylord National Harbor facility south of Washington DC.

#### **WEDNESDAY**

#### REGISTRATION

Confirmed pre-registration for convention events at 7:00 AM.

#### **GOVERNMENT vs. COMMERCIAL CONSTRUCTION CONTRACTS & SPECIFICATIONS**

I did not pre-register for this seminar, however was able to do so last minute. There were two presenters, one taking side of Government (Joseph Scarpa) and other the side of Commercial projects (Elias Saltz). Rita was also in the seminar. Time - Attended 45 of 60 minutes before having to leave for the tour.

#### TECHNICAL TOUR

Behind the scenes of Washington National Cathedral, second largest in the US. Reviewed building history, damaged caused by 2011 earthquake, walked above nave, altar, and in transept gutters. Saw building models, plaster model of high altar stonework, and other models that are being sent to a museum. Tour led by James Shepherd, AIA and stone mason who has worked on building since 1985. Latter explained how initial stonework is done today with computers. About 30 attendees; sold out. Tour Time - Approximately 1-1/2 hours.

#### LUNCHEON

Presentation by Dr. James Richardson, world champion athlete and Olympian, who talked about how one's BS can affect their potential. Learn how to override the negativity that gets in the way of your potential by building better beliefs. BS = Belief System. 1 - Negative Results; 2 - Negative Actions; 3 - Negative Feelings; 4 - Negative Beliefs; 5 - Positive Belief; 6 - Positive Feelings; 7 - Positive Actions; and 8 - Positive Results. Rita and I attended, along with about 100 others.

#### SPECIFYING INTERIOR FINISHES

Presenter (Ivette Bruns) discussed different types of interior finishes that require assistance from product representatives to provide complete and correct specifications. The issue relates to more than just selecting material color. The differences between information on product data sheets, websites, and true CSI guide specs were mentioned. Some of other concepts presented: floor moisture and water-based adhesives; frequently forgotten items and who provides them (types of underlayment due to incorrect concrete FF); wood veneer cuts and effects on aesthetics; and types of ceramic grouts. Time - One hour.

#### October-November 2019

#### OH NO! WHAT DID I MISS? HOW TO PROPERLY SPECIFY AN AIR BARRIER SYSTEM

Presenter (Ryan Dalgleish) mentioned importance of knowing proper concepts, reference standards, and materials to prepare correct specifications. Various ASTMs were discussed and how they differ in building outcomes. While products between manufacturers are not that different, compatibility of products from various manufacturers can determine if a system works properly. Also discussed adhered systems vs. mechanical systems. City of Seattle now mandates testing to receive an occupancy permit. Time - One hour.

#### FIVE DISRUPTIVE TECHNOLOGIES THAT WILL CHANGE SPECIFICATIONS FOREVER

Architect (Paul Doherty) presented: #1 - Machine learning, i.e., Artificial Intelligence (AI); #2 - Voice Assistance and what is happening with communications; #3 - Big Data and accessibility analytics that allow machines to talk to machines; #4 - Augmented / Virtual Reality using examples of China theme park and eSports Arena; and #5 - BIM. Time - 1-1/2 hours.

#### **CSI REGION CAUCUSES**

This was an attendance requirement to receive Pittsburgh Chapter reimbursement. Rita and I attended the Middle Atlantic Region meeting that lasted about 30 minutes.

#### WELCOME RECEPTION

Heavy hors d'oeuvres allowed convention attendees to mingle. Rita and I talked with a gentleman (RA) from Arkansas until we had to leave.

#### DINNER

Rita and I went to a local restaurant and met Ken Chappel, our contact from specification consultant Mark Kalin and a friend. We had a two-hour dinner / talk about various issues related to specifications.

#### **THURSDAY**

#### UNDERSTANDING DIFFICULT TRANSITIONS OF AIR/VAPOR/MOISTURE BARRIERS

This was my only AM seminar. Presenter (Corey Zussman) is an architect who works for a general contractor and used real world examples showing that the devil is in the details. Various concepts included: compatibility between system materials and substrates; proper sequencing of the work (do not put windows in before barrier); create PROPER DETAILS; peel n stick systems have issues; incompatibility between barriers and fireproofing; and new Illinois energy code requires stopping air under deck into parapets. Time elapsed prior to completing slides. Time - 1:15 (75 minutes).

#### CONTRACTOR CONFESSIONS TO HELP IMPROVE YOUR SPECIFICATIONS AND DRAWINGS

This was my only PM seminar. Same presenter as AM session (Corey Zussman), this time not limited to weather barrier systems. Some of discussed concepts: unless a wind speed is stated, roof warranty in only valid to 55 MPH (72 MPH at no additional cost); treated wood and galvanized metal issues; wood soffit overhang limitations; roof pitches and sloped structural steel issues with drains; concrete, including finishing, chair placement details, tolerances, curing; live load and deflection; windows and fasteners; and waterproofing, including types of, and not using braided wire (use conduit). Time elapsed prior to completing slides. Time - 1-1/2 hours. Talked to presenter and received link to access his website for additional information.

#### October-November 2019

EXPO HALL LEARNING LOUNGE - PAINT TECHNOLOGY: CHEMISTRY AND PERFORMANCE? In Benjamin Moore Booth and related to current technology and its impact on paint application and performance. Talked with speaker after presentation, who indicated that PDF would be sent to me. Time - About 30 minutes.

EXPO HALL LEARNING LOUNGE - AN INTRODUCTION TO HIGH PERFORMANCE COATING SYSTEMS? In Benjamin Moore Booth and was given by presenter of previous session. This was a general presentation on epoxy and other systems. Talked with speaker after presentation, who indicated that PDF would be sent to me. Time - About 30 minutes.

#### EXPO HALL LEARNING LOUNGE - WHY PAINT PIGMENTS MATTER?

In Benjamin Moore Booth and related to pigment components and their impact on paint application and performance. This was similar to first LL present. Talked with speaker after presentation, who indicated that PDF would be sent to me. Time - About 30 minutes. These same 3 sessions were available on Friday during show times.

The Expo Hall was available between AM and PM seminars: roughly 9:00 PM - 3:00 AM. There were approximately 150 vendors, plus a Demonstration and Learning Theater and a Coffee Talk Lounge. Met with various representatives during open times. There was no breakfast or lunch; snacks were available at coffee stations.

CSI AWARDS CEREMONY Did not attend.

#### DINNER

Rita and I met at a local restaurant and talked shop.

#### **FRIDAY**

#### THE LOVE / HATE RELATIONSHIP OF MOISTURE IN CONCRETE FLOOR SLABS

While water is an essential concrete ingredient, too much or too little can cause various issues during placement, finishing, and curing. There were two presenters: one doing the love side (Scott Tarr) and other doing hate side (Peter Craig). This was a very good presentation. This was the only seminar I attended that did NOT post the slide show online prior to the convention; hence, no place to make the few notes I made. They started with the 4 types of concrete: bookcrete (what text books say); labcrete (what lab tests indicate); realcrete (concrete that is actually placed); and legalcrete (what attorneys say was placed and owned or not). Time - 1-1/2 hours.

#### SPECIFICATIONS: QUALITY CONTROL AND COORDINATION

Presenter (Michael Chambers) is a Fellow of both AIA and CSI. Issues of Quality Control and Quality Assurance were addressed within CD package. While no quality issues are included on Drawings, quality is best described in Various Division 01 Sections. Then went through various Division 01 Sections describing how quality statements can be used. Time - 1-1/2 hours.

#### EXPO HALL DEMONSTRATION THEATER - SPECIAL POWDER COATING

Presenter (James Hester from his company QPC) is a powder coat applicator from Texas who had an Expo booth. Discussed AAMA standards, the application process, and current technology that permits wood grain, stone, and tile aesthetics (patterns and textures). Even a color photograph can be applied to a substrate, typically aluminum. Time - About 30 minutes. Also had a long talk with him and woman from powder coat manufacturer at his booth.

EXPO HALL COFFEE TALK LOUNGE - 5 CONSIDERATIONS WHEN SPECIFYING MANUFACTURERS Presenter (Denise McDaniel) from Deltek. Time - About 15 minutes.

EXPO HALL COFFEE TALK LOUNGE - GREAT FIRE OF LONDON: RAIN SCREENS, CLADDINGS, AND CONTINUOUS INSULATION

Presenter was Joseph Lstiburek. Time - About 15 minutes.

The Expo Hall was available after seminars: roughly 9:00 PM - 2:30 AM.

There were approximately 150 vendors, plus a Demonstration and Learning Theater and a Coffee Talk Lounge. Met with various representatives during open times. There was no breakfast or lunch; snacks were available at coffee stations.

#### CSI BUSINESS MEETING

This was an attendance requirement to receive Pittsburgh Chapter reimbursement. Time - About 45 minutes.

#### **DEPARTURE**

Leave resort about 6:00 PM, arriving home just before midnight; roughly 6 hours, which included a wrong turn that took about 45 extra minutes. Checked out of the hotel at 7:00 AM before the day began.

#### **CONVENTION SUMMARY**

This was my first CSI national convention since joining the Pittsburgh Chapter in 1981. It was HIGHLY motivational and WELL worth attending.
