PRESIDENT'S MESSAGE

Over 75 years ago, the construction industry was not so smoothly structured when it came to construction documents and how designers and contractors communicated. It was a free for all during a time that the U.S. construction industry was booming. Specification writers in government agencies stepped in to develop some standard formats for



everyone to follow. What we take for granted now, was a monumental step forward in allowing all parts of the construction industry to speak together in a common language or manner.

This month's program, "Taming the Specifications Beast" is meant to help all parts of the construction industry understand the importance of specs and how to make them easier to develop. The days of the master specifications writer toiling away with his green plastic visor are gone. We now have many designers developing their own specifications, sometimes with guidance, and sometimes all alone. CSI and our Pittsburgh Chapter are always here to help newbies (and the established) understand specifications and make their jobs easier. Our trusted advisors, our product reps, are here to educate you about how to specify products and to understand today's complicated building systems. CHAPTER BY-LAWS CHANGE

CSI Pittsburgh Chapter Governance and Bylaws Change

The CSI Pittsburgh Chapter Board approved changing the number of board members at its July board meeting. At one time, the chapter had over 200 members but in recent years we have been hovering around 70-80 chapter members. Due to this decrease, it was felt that we should shrink the size of the board as well. To allow members to move up the officer ranks quicker, it is proposed to eliminate the 2nd Vice President (VP) position. Eliminating the 2nd VP will allow a member to become President within 2 to 4 years instead possibly 8 years.

It is also proposed to eliminate the position of Advisor and replace it with the Immediate Past President position which occurs with most other organizations. In the past, a president would be an advisor for 3 2-year terms which means that person would been on the board for over 10 years.

Hopefully these changes will streamline the chapter and make us a more nimble organization. As required by the current bylaws any change to the bylaws requires a 2/3 majority of the voting members present at its next regular meeting on September 10.

Section 2. Composition of Board

A. The board shall consist of not less than fifteen eleven (1511) members as follows: 1) President, 2) First Vice-President, 3) Second Vice-President, 4) Secretary, 5) Treasurer, Immediate Past President, and Sixeven (67) elected Directors, and three (3) Advisory members. The three Advisory members shall be recent past presidents including the Immediate Past President, who choose to serve and who shall form a Long-Range Planning Committee among other duties. Emerging Professional members may serve in any of the elected positions.

Other sections which mention these positions will be updated.

A section on indemnification has also been added since this occurs with most boards.

Section 7. Indemnification

A. Directors, officers and other authorized employees or agents of the Chapter shall be indemnified against claims for liability arising in connection with their positions or activities on behalf of the Chapter to the full extent permitted by law.


IN MEMORIAM - CHARLES A. BROWN

Charles Alden Brown

Charles A. Brown, 82, passed away peacefully on August 25, 2024, in Edison, New Jersey. Born in Chicago to William and Margaret Brown, he lived in Pittsburgh for most of his life before moving to NJ in June. Charlie was a prominent Pittsburgh architect and a devoted man of faith who shared personality traits with the comic character who shares his name. He leaves behind a legacy of dedication, both in his professional life and in his commitment to his community and family.

As he was finishing his Architectural studies at the University of Illinois, he was drafted into the U.S. Army during the Vietnam conflict, and used his drawing skills in a mapping state-side position. After his discharge from service, Charlie

married the former Marie Maudlin and worked for the American Baptist Convention, helping congregations site and plan church buildings.



For many years, Charlie was an active member of the First Baptist Church of Crafton, PA, where he was involved in ministry and leadership. He also served the broader community through his involvement with the American Baptists Association of Pittsburgh. His contributions to these organizations were marked by his passion for service and his unwavering faith. Charlie had a quiet presence, never seeking to be the center of attention or demanding his way, yet his influence was deeply felt by all who knew him. He had a playful, self-deprecating sense of humor that played off his Charlie Brown character and he was universally liked. Despite being thrifty, he was known for his generosity with his time and money.


As a hobby, Charlie worked for years renovating his home. It is hard to remember a time during which part of his home was not under construction and he practiced all trades. He loved jigsaw puzzles and games, and had a passion for computers and technology. After retirement, he transitioned to becoming a full-time caregiver for his beloved Marie, who suffers from Alzheimer's disease. Charlie and Marie were known for their frequent walks in their neighborhood during the time he cared for her there.

With his own serious health issues mounting, Charlie moved with Marie to NJ under the care of relatives this past June, only to experience additional setbacks. Through it all, he remained the same kind, gregarious person he has always been, charming hospital staff with his humor and soft-spoken manner. He left this life as the same loving soul who cared for others and had deep faith in humanity and his religious convictions throughout his life.

Charlie was predeceased by his parents, his daughter, Heather Brown, in 2010, and his brother, Gorden Brown, in 2024. He is survived by his loving wife, Marie Brown; his brother, Donald Brown, and brother-in-law, Chris Parsons, of Los Angeles, CA; his sister-in-law, Jean Brown, of Peoria, IL; his son, Alex Brown, and daughter-in-law, Priscilla M. Hockin Brown of Metuchen, NJ; his son-in-law, Craig Hinds, and daughter-in-law, MaryJo Hinds, of Manalapan, NJ; his beloved grandchildren, Erica, August, Forest, Rowan, William, and Parker; and many nieces, nephews, and cousins. His family, friends, and colleagues will remember him as a man of humble integrity, abundant kindness, playfulness, and dedication to serving others.

A memorial service will be held to honor Charlie's life and legacy on 11:00 am September 21st, 2024, at the First Baptist Church of Crafton, 1 Oregon Ave, Crafton, PA 15205. In lieu of flowers, the family requests that donations be made in his memory to the First Baptist Church of Crafton, the American Baptists Association of Pittsburgh, the Alzheimer's Association, or the Lupus Foundation of America.

Charles A. Brown will be deeply missed by all, but his spirit will live on in the hearts of those who knew and loved him.




